 - i. Concern about how to retain students.

 1. Senator Hayashi provided a demonstration of the TurningPoint clicker technology that is being proposed as a method for voting senators to cast votes anonymously.
 2. The Senate will try the TurningPoint clicker technology at its next meeting on September 20, 2017.
- C. Senator May voiced his concern regarding the perceived inconsistent understanding and application of UH Community Colleges' tenure and promotion guidelines among Leeward CC Division Personnel Committees (DPCs).
 1. The issue was referred to the Faculty Committee for review and recommendation.
